PRAISING GOD FOR HIS GOODNESS

"They shall utter the memory of your great goodness and shall sing of your righteousness" (Psalm 145:7 NKJV).

Note that the Psalmist insisted on an abundance of praise in memory of the Father's goodness; they sang the Hebrew for abundant utterances, "to gush out like water rushing from a fountain."

In Psalm 107:8-9, David wrote, "Oh, that men would give thanks to the Lord for his goodness, and for his wonderful works to the children of men! For he satisfies the longing soul and fills the hungry soul with goodness."

This truth of praising God for his past goodness struck a chord in my heart, and I have been moved to do as David did. We are called upon to celebrate his goodness.

David examines the beauty of this goodness. Notice that God is inclined to use mercy because he sympathizes with our affliction and miseries; mercy is his default sentiment toward us. David borrowed from Exodus 34:6, where God spoke to Moses: "And the Lord passed before him and proclaimed, 'The Lord, the Lord God, merciful and gracious, longsuffering, and abounding in goodness and truth.'"

State Liability Insurance Provider: Lockton Affinity

General Guidelines

Policy: The insurance policy is a 2nd party general liability policy. It is meant to protect the Council and facilities utilized for Council activities.

Policy does not cover Knights individually, your own personal insurance policy is your coverage at events, etc. Exception: LAMB has its own insurance policy, contact LAMB Treasurer for further information. The policy covers guests at activities sponsored by a Knights of Columbus Council. Policy is not collision insurance but liability insurance.

General Liability: \$1,000,000 per occurrence, \$3,000,000 aggregate Products-Completed Operations: Included in General Aggregate Limit Personal and Advertising Injury: \$1,000,000 Damage to Premises Rented to You: \$1,000,000 Medical Expense- any one person: \$20,000 Hired and Non-Owned Auto Liability: \$1,000,000 per occurrence Sexual Abuse and Molestation: \$500,000 per occurrence, \$500,000 aggregate

Acceptable Events/Activities - Local Council Meetings, Marching in Parades, Local Council Parties for Members and Guests, Communion Breakfasts, Basketball Free-Throw Contests, Soccer Challenge, Poster Contests, Prayer Services, Scholarships, Luncheons/Picnics, Food & amp; Clothing Drives, Family Trips, Honors for Police, Fire Fighters, Veterans and other Appreciation Events, Car Washes, Church Work: Ushers, Lectors, Choir, Youth Ministry, Bingo, Supporting poor and needy, Home/school association support, Tootsie roll & amp; Candy sale, Tournaments: Golf, Bowling, Billiards, Baseball, Softball, Youth awards Senior citizen support: visit and equipment donations, Local council promotional activities, Keep Christ in Christmas: Billboards, mangers,

cards, Adoption Education Programs, Funeral Service Rituals, Casino nights, Easter Seals, Voter Registration.

Key Exclusions – Athletic Or Sports Participants - this insurance does not apply to "bodily injury"; to any person while practicing for or participating in any sports or athletic contest or exhibition that you sponsor. This exclusion does not apply to:

Basketball Free Throw Soccer Challenge Golf Tournament and Softball/Baseball Games.

Exclusion – Designated Ongoing Operations – "bodily injury"; or "property damage"; arising out of the ongoing operations involving activities described below is excluded:

Firearms Altercations with Demonstrations at Right to Life Events Sponsorship of Carnivals, Circuses and Fairs. Rock Concerts Activities involving Amusement Devices such as Rides, Inflatables, or similar devices.

Exclusion – Liquor Liability This insurance does not apply to "bodily injury"; or "property damage"; for which any insured may be held liable by reason of:

 Causing or contributing to the intoxication of any person, including causing or contributing to the intoxication of any person because alcoholic beverages were permitted to be brought to your premises, for consumption on your premises.
The furnishing of alcoholic beverages to a person under the legal drinking age or under the influence of alcohol; or

3. Any statute, ordinance or regulation relating to the sale, gift, distribution, or use of alcoholic beverages.

This exclusion applies only if:

You are in the business of manufacturing, distributing, selling, serving or furnishing alcoholic beverages; or

For any event with liquor provided by the Insured if a license is required for such activity

Exclusion – Athletic Or Sports Participants - this Policy does not apply to Claim made against any Insured based upon, arising out of, relating to, directly or indirectly resulting from or in consequence of, or in any way involving "Brain Injuries" actually, allegedly or potentially sustained by a "Participant" in any sports or athletic game, contest, event, exhibition or practice. The term "Participant" shall mean any past, present or future member of a team.

The Knights of Columbus Local Councils Insurance Program Directors and Officers \$250,000 Per Council, \$2,000,000 Aggregate

How is it Financed:

Each Council is assessed \$2.00 per active member per year for this insurance on August 15th based on August 1 roster billed on their August State Insurance Bill Council hosts a fish fry and a Knight accidentally receives a hot oil burn. Not covered by this policy.

Council hosts a fish fry and a guest accidentally receives a hot oil burn. Covered. Host a Bingo – guest falls and gets injured. Covered.

Frequently Asked Questions: (FAQ)

Q: What is a Certificate of Insurance?

A: A certificate issued by the insurance company that verifies a valid policy is in effect for the Knights of Columbus

Q: When do I need a Certificate of Insurance? A: When the owner of the property you are planning on conducting an event requests one. This could be Church property, public property, i.e. park, etc.

Q: What if the Parish requests a Certificate of Insurance to cover all Knights of Columbus activities on Church property for the year.

A: A Certificate of Insurance will be issued upon request.

Q: How do I get a Certificate of Insurance?

A: Contact the State Advocate (e-mail or telephone).

Q: What about alcohol sales at an event?

A: A Certificate of Insurance is not a permit to sell alcoholic beverages. A one-time event permit should be secured from the North Carolina ABC commission.
